THE RESIN EMBLEM ON THE DRIVER S AIRBAG MODULE COVER IN AFFECTED VEHICLES MAY HAVE REDUCED DURABILITY DUE TO POTENTIAL SUPPLIER PRODUCTION PROCESS VARIATION. IN THIS CONDITION, OVER TIME THE POSTS OF THE EMBLEM MAY DEVELOP CRACKS, AND THE EMBLEM AND RETAINER COMPONENTS COULD DETACH IN THE EVENT OF AN AIRBAG DEPLOYMENT.

Remedy

Dealers will inspect and, if necessary, replace the Driver Airbag Cover.
